2. You need to complete the identity verification and account registration to participate in AGM 2026 and cast your votes electronically via the AGM Website. The registration and voting period will open at **12:00 (GMT+7) on March 27, 2026, and close at 16:00 (GMT+7) on April 18, 2026**. Detailed instructions for account registration, attendance, authorization, and voting are provided in the Account Registration Guidelines at mwg.vn.

You may authorize an individual or organization to receive account information to sign in to the AGM Website for attending AGM 2026 and fully execute all shareholder rights including discussion and voting, with all voting rights that the shareholder holds in accordance with the Company’s regulations. The Power of Attorney template is uploaded in the AGM 2026’s Documentation at mwg.vn.
4. **Date, time, and venue of AGM 2026:**
 - Opening time: **13:30 to 16:00 on Saturday, April 18, 2026 (GMT+7)**.
 - Venue: MWG Building, T2-1.2, D1 Street, Saigon Hi-tech Park, Tang Nhon Phu Ward, Ho Chi Minh City.
 - Account signing up and meeting registration: **from 12:00 of March 27, 2026 (GMT+7)**, via the website.
 - Ballot Collection Time: **15:00 (GMT+7), April 18, 2026**.
5. **Participants:** All shareholders whose names are recorded on the shareholder list of MWG as of March 16, 2026, provided by the Vietnam Securities Depository and Clearing Corporation (VSDC).
6. **The agenda and other documents** will be published on the mwg.vn website by March 26, 2026.
