

**GUIDELINES FOR SHARE SUBSCRIPTION AND PAYMENT
FOR THE INITIAL PUBLIC OFFERING OF SHARES
OF DIEN MAY XANH INVESTMENT JOINT STOCK COMPANY**

These guidelines for share subscription and payment (“**Guidelines**”) are intended to guide investors (“**Investor**”) in carrying out the necessary procedures to subscribe for, pay for, and record Investors’ ownership of shares offered by Dien May Xanh Investment Joint Stock Company (“**DMX**”) in its initial public offering (“**Offering**”) pursuant to Certificate of Registration for Initial Public Offering No. 106/GCN-UBCK issued by the Chairperson of the State Securities Commission (“**SSC**”) on 21/05/2026 (“**Offering License**”), the Prospectus dated 19/05/2026, and DMX’s Notice of Initial Public Offering of Shares.

The subscription, payment, and recognition of Investor ownership shall be deemed valid only when carried out in accordance with the provisions of these Guidelines.

Note:

- *The timelines in Step 1 and Step 3 above refer to the time at which DMX (or through the Distribution Agent) receives the valid Registration Dossier.*
- *DMX has the right to adjust or extend the timelines in this Section I.2 in accordance with applicable law. Any changes shall be officially notified to Investors by DMX or the Distribution Agent.*
- *(*) If DMX receives the Deposit after the specified deadline, DMX shall have sole discretion to decide whether the Investor’s subscription order shall be treated as a Valid Subscription Order in accordance with Section I.3.1 of these Guidelines.*

- (**) If DMX receives Share subscription payments after the specified deadline, DMX shall have sole discretion to decide whether to allocate Shares to the Investor in accordance with Section I.3.2 of these Guidelines.

3. RULES ON SUBSCRIPTION, DEPOSIT, AND PAYMENT PROCEDURES FOR INVESTORS

3.1. Rules on Share subscription and Deposit payment

3.1.1. Investors subscribe for Shares through the Distribution Agent throughout the subscription period: detailed guidance in Section II of these Guidelines.

3.1.2. Investors must complete and correctly fill in all information on the Share Subscription Form and submit it to the Distribution Agent:

- a) The Share Subscription Form must be in DMX's official template, available on DMX's website at www.dmx.vn or on the Distribution Agent's website;
- b) The Investor's Share Subscription Form (where submitted in hard copy) must be free from tears, damage, dirt, or stains; information must be clearly presented, free of erasure and free of any sign of modification.

3.1.3. Every Investor's Share Subscription Form shall be assigned by DMX a unique dossier code ("**Dossier Code**") associated with the Investor's Share Subscription Form and notified to the Investor. This Dossier Code is unique, cannot be changed, and serves as the basis for the Investor to make payment of the share subscription price.

3.1.4. An Investor's Share subscription shall be deemed valid ("**Valid Subscription Order**") when DMX has received the Investor's subscription information in accordance with the following method and conditions of receipt:

The Investor's Registration Dossier(s) for the Shares are correspondingly reflected on the list of Investors ("**Investor List**") provided by the Distribution Agent to DMX, which records that the Investor has transferred the full Deposit into the Escrow Account before 16:00 on the same day DMX receives such Investor List, and DMX has received the full Deposit in the Escrow Account.

The "**Subscription Date**" of each Valid Subscription Order shall accordingly be the time at which DMX receives the Registration Dossier / Investor List of such Valid Subscription Order in accordance with the principles set out in this Article.

3.1.5. The Investor shall pay the Deposit into the Escrow Account on the same day stated on the Share Subscription Form, within the period specified in Section I.2 above. The Distribution Agent is responsible for compiling and sending DMX, throughout the subscription period, the Investor List of those who have submitted their Registration Dossiers and transferred their Deposits on that day.

3.1.6. An Investor may subscribe and submit Share Subscription Forms multiple times in a day and on different days during the subscription period, provided that the total does not exceed the maximum number of Shares subscribable by one Investor under Section

I.1.12 of these Guidelines; any excess shall be automatically cancelled (not recorded for Share allocation).

- 3.1.7. In no event may an Investor amend or cancel any Valid Subscription Order(s).
- 3.1.8. Only Valid Subscription Orders shall be finalized by DMX for allocation of the right to purchase Shares pursuant to Section I.3.2 of these Guidelines.
- 3.1.9. The Deposit and/or Total Subscription Value are calculated using the following formulas:
- **Total Subscription Value** = Offering Price x (multiplied by) the number of Shares subscribed by the Investor.
 - **Deposit** = 10% x (multiplied by) Total Subscription Value
- 3.1.10. If the transfer description for the Deposit is incorrect or incomplete per the instructions, the Investor must carry out bank tracing/correction procedures and provide the traced/corrected documents with bank confirmation no later than **16:00 on June 17, 2026**. If DMX confirms successful receipt of the Deposit after tracing, the Valid Subscription Order shall still be deemed submitted on the relevant Subscription Date.
- 3.1.11. If DMX receives the Deposit after the specified deadline, the Investor shall provide DMX with documents evidencing that the Investor paid the Deposit on the Subscription Date (including but not limited to: bank statements, confirmations from the relevant bank, etc.) before **16:00 on June 17, 2026**. If DMX assesses and confirms that the Investor paid the Deposit before the specified deadline, the Investor's Share subscription shall be deemed a Valid Subscription Order.
- 3.1.12. If the amount paid by the Investor as Deposit is less than the Deposit stated in the Share Subscription Form, DMX has full discretion to: (i) require the Investor to pay additional Deposit in accordance with the corresponding Share Subscription Form before 16:00 on the same day stated on the Share Subscription Form, or (ii) require the Investor to adjust the number of Shares subscribed on the Share Subscription Form to match the proportion of the amount paid before 16:00 on the same day stated on the Share Subscription Form, or (iii) apply any other remedy DMX deems appropriate.

If the Investor complies with the instructions in (i) or (ii), or with DMX's remedy in (iii), the subscription order shall be deemed a Valid Subscription Order.

If the Investor fails to comply with the instructions in (i) or (ii), or with DMX's remedy in (iii), the subscription order shall be deemed an Invalid Subscription Order.

3.2. Share allocation principles:

- 3.2.1. Upon expiry of the subscription period, DMX shall compile the number of Shares subscribed under Valid Subscription Orders received from the Distribution Agent and allocate Shares to Investors in a public, fair, and transparent manner.
- 3.2.2. Shares allocated to Investors ("**Allocated Shares**") per Valid Subscription Order at each Distribution Agent shall be calculated as follows:

$$\text{Allocated Shares} = \text{Number of Shares subscribed by Investor} \times (\text{multiplied by}) \text{ Allocation Ratio}$$

- If the total number of Shares subscribed is less than or equal to the total number of Shares permitted to be offered under the Offering License, Shares shall be allocated to Investors in the exact number subscribed under the Valid Subscription Order(s).
- If the total number of Shares subscribed exceeds the total number of Shares permitted to be offered under the Offering License, Shares shall be allocated to Investors in the following ratio (“**Allocation Ratio**”):

$$\text{Allocation Ratio} = \frac{179,500,400 \text{ Shares}}{\text{Total number of Shares subscribed by Investors under Valid Subscription Orders}}$$

- Rounding and handling of fractional shares (if any): The number of Allocated Shares shall be rounded down to the nearest whole share; any fractional amount (if any) shall be allocated as decided by DMX’s BOD after the payment period ends.

Example: Assume an Allocation Ratio of 88.88% (0.8888). An Investor with 2 Valid Subscription Orders shall be allocated as follows:

No.	Shares subscribed	Shares allocated by ratio	Fractional shares	Shares allocated for purchase
Order 1	1,000	888.8	0.8	888
Order 2	2,000	1,777.6	0.6	1,777
Total	3,000	2,666.4	1.4	2,665

Per the above example: The Investor is allocated to purchase a total of 2,665 shares (Order 1: 888 shares; Order 2: 1,777 shares). The fractional 0.8 shares in Order 1 and 0.6 shares in Order 2 are not allocated and shall be treated as fractional Undistributed Shares, to be handled and allocated at a time to be determined by DMX’s BOD after the share subscription payment period ends.

- 3.2.3. DMX shall send the Investor’s Allocation Result Notice to the Distribution Agent, who shall forward it to the Investor.
- 3.2.4. The Allocation Result Notice sent to the Investor via the Distribution Agent shall include key information on (i) the Allocated Shares per Valid Subscription Order at such Distribution Agent, (ii) the purchase value of the Allocated Shares per Valid Subscription Order at such Distribution Agent (“**Allocated Value**”); (iii) the Outstanding Purchase Amount per Valid Subscription Order per the formula below, and (iv) instructions for payment of the Share purchase price.

For the purposes of this Article:

Outstanding Purchase Amount = Allocated Value – (less) **Amount Paid** (including Deposit(s) and any overpaid amounts during the subscription period). If the Outstanding Purchase Amount is less than or equal to zero, the Investor shall not be required to pay any additional amount.

Allocated Value = Offering Price x (multiplied by) Allocated Shares

3.3. Payment and refund principles

3.3.1. Payment principles:

- a) After receiving the Allocation Result Notice, the Investor shall pay for the Allocated Shares in accordance with the payment instructions sent by the Distribution Agent in the Allocation Result Notice **before 16:00 on June 29, 2026 (“Subscription Payment Deadline”)**. Late, incomplete, or untimely payment, or other cases that do not comply with the payment instructions, may result in the Investor: (i) not being permitted to purchase any Shares under the Allocation Result Notice and forfeiting the entire Deposit paid, or (ii) being permitted to purchase only the number of Shares corresponding to the amount paid and the relevant Valid Subscription Order per Section I.3.3.2 of these Guidelines, at DMX’s discretion.
- b) If DMX receives from the Investor more than the Outstanding Purchase Amount for a Valid Subscription Order under each Allocation Result Notice: the Investor shall be permitted to purchase all Shares under the Allocation Result Notice and shall be refunded any excess over the Allocated Value in accordance with the refund principles detailed in Section I.3.3.3.
- c) If DMX receives less than the Outstanding Purchase Amount or does not receive the Outstanding Purchase Amount, DMX has full discretion to: (i) accept the sale of the number of Shares corresponding to the amount paid by the Investor and the relevant Valid Subscription Order, or (ii) refuse to sell any Shares to the Investor and retain the Deposit, or (iii) apply any other remedy DMX deems appropriate.
- d) If the Investor has multiple Valid Subscription Orders, the Investor must make payment and/or authorize the Distribution Agent to deduct payment (subject to the payment rules at each Distribution Agent set out in Section I.3.3.2 of these Guidelines) for the Outstanding Purchase Amount separately for each Valid Subscription Order and Allocation Result Notice in order for the payment to be validly recorded. If the Investor pays into the Escrow Account without separating amounts per Valid Subscription Order and without specifying which Valid Subscription Order the payment relates to, DMX shall have full discretion to allocate the amount paid by the Investor (**“Unallocated Payment Amount”**) to the Investor’s Valid Subscription Orders in accordance with the principles set out in Section I.3.3.2 of these Guidelines.
- e) If the payment description is incorrect or otherwise invalid per the Allocation Result Notice such that the Investor’s intent in making payment cannot be determined, the Investor must carry out bank tracing/correction procedures and provide traced/corrected documents with bank confirmation before **16:00 on June 29, 2026**.

If DMX confirms that the traced/ corrected documents provided by the Investor are valid, DMX shall record the payment result and the number of Shares the Investor has successfully purchased.

- f) If DMX receives the Outstanding Purchase Amount after the specified deadline, the Investor shall provide DMX with documents evidencing that the Investor paid the **Outstanding Purchase Amount** before **16:00 on June 29, 2026** (including but not limited to: bank statements, confirmations from the relevant bank, etc.). If DMX confirms that the documents provided by the Investor are valid, DMX shall record the payment result and the number of Shares the Investor has successfully purchased.

3.3.2. Payment procedures and principles at the Distribution Agent

- a) During the Payment Period:

- The Investor makes payment in accordance with the **Distribution Agent's payment instructions sent in the Allocation Result Notice**;
- Payment deadlines, amounts, transfer descriptions, and bank tracing/correction procedures (if any) shall be carried out in accordance with the Distribution Agent's notice.

- b) Principles for allocating amounts paid by the Investor where the Investor does not separate payments by Valid Subscription Order:

After the Subscription Payment Deadline, DMX shall aggregate and process the total Unallocated Payment Amount during the Payment Period under the following principles:

- If the total Unallocated Payment Amount \geq total Outstanding Purchase Amount: DMX shall record payment for all of the Investor's Valid Subscription Orders.
- If the total Unallocated Payment Amount $<$ total Outstanding Purchase Amount: DMX shall have full discretion to record payment in accordance with the following principles:
 - o Payment shall first be recorded for the Valid Subscription Order with the largest Outstanding Purchase Amount, then in descending order. Where two or more Valid Subscription Orders have the same Outstanding Purchase Amount, priority shall be given to the Valid Subscription Order with the earliest Subscription Date.
 - o The amount recorded as payment for each Valid Subscription Order shall equal the Outstanding Purchase Amount for that order (**“Recorded Payment Amount”**).
 - o If the total Unallocated Payment Amount is insufficient to pay the Outstanding Purchase Amount of the Valid Subscription Order under consideration in the priority order above, DMX shall **skip that Valid Subscription Order** and continue to consider recording payment for the next Valid Subscription Order with a lower value.

- o Payment allocation shall continue until the total Unallocated Payment Amount is **fully used**, or until the total Unallocated Payment Amount is **insufficient to pay any remaining unpaid Valid Subscription Order in the list**.

Illustrative Examples

Example 1: Investor pays in full for all Valid Subscription Orders

Investor A has 2 Valid Subscription Orders at the Distribution Agent, with the following details:

Assume an Allocation Ratio of 50%. The Allocated Shares and Outstanding Purchase Amount for each order are as follows:

During the Payment Period: The Investor pays **VND 352,000,000** into the Escrow Account but does not specify which Valid Subscription Order the payment is for.

⇒ After the Subscription Payment Deadline: DMX shall record payment for both Valid Subscription Orders. Total Recorded Payment Amount = **VND 352,000,000**.

⇒ Shares successfully purchased by the Investor: **5,500 Shares**.

Example 2: Investor pays part of the total Outstanding Purchase Amount for the Valid Subscription Orders

Investor B has 3 Valid Subscription Orders at the Distribution Agent, with the following details:

Assume an Allocation Ratio of 50%. The Allocated Shares and Outstanding Purchase Amount for each order are as follows:

During the Payment Period: The Investor pays **VND 401,000,000** into the Escrow Account but does not specify which Valid Subscription Order the payment is for.

=> After the Subscription Payment Deadline: DMX shall record payment under the principles set out in this Section as follows:

- Priority: record payment for the Valid Subscription Order with the largest Outstanding Purchase Amount, descending. Priority: Valid Subscription Order 3 > Valid Subscription Order 1 = Valid Subscription Order 2.
 - Where two or more Valid Subscription Orders have the same Outstanding Purchase Amount, priority is given to the Valid Subscription Order with the earliest Subscription Date: Priority Valid Subscription Order 1 > Valid Subscription Order 2.
 - Accordingly: DMX records payment for Valid Subscription Order 3 and Valid Subscription Order 1. Valid Subscription Order 2 is unpaid, and the Investor shall not be allowed to purchase shares under its Allocation Result Notice, and the Deposit for that order shall not be refunded.
- ⇒ Shares successfully purchased by the Investor: **6,000 Shares**.
- ⇒ Total Recorded Payment Amount for Valid Subscription Order 3 and Valid Subscription Order 1: **224,000,000 + 160,000,000 = VND 384,000,000**.
- ⇒ The Investor shall forfeit the Deposit for Valid Subscription Order 2.
- ⇒ The Investor shall be refunded* the excess of **VND 17,000,000** (= Amount paid during the Payment Period – Total Recorded Payment Amount) after allocation of payment to Valid Subscription Order 3 and Valid Subscription Order 1.

**See detailed refund and Deposit handling principles in Section I.3.3.3*

3.3.3. Refund and Deposit handling principles

- a) Refund cases shall be determined by DMX **separately for each Valid Subscription Order**. A single Investor may receive multiple refunds, depending on the number of Valid Subscription Orders meeting the refund criteria. Refunds **are not based on the total amount paid and total allocated value for the entire offering** but are calculated independently for each Valid Subscription Order.
- b) DMX shall refund overpaid amounts to the Investor within 10 days from the date of the State Securities Commission's official letter confirming receipt of DMX's report on the results of the public share offering and DMX's completion of procedures to release the proceeds from the Offering.
- c) DMX shall refund any amounts (if any) to the Investor's bank account as recorded on the Share Subscription Form.
- d) Refund and Deposit handling cases:
 - An Investor whose Valid Subscription Order has been confirmed but who is subsequently not allocated (allocated shares = 0) for objective reasons and through no fault of the Investor, including but not limited to:
 - Technical errors arising from the trading system or order receipt system of the Distribution Agent;
 - Data discrepancies caused by input errors from the intermediary, not originating from the Investor;

- Changes in law or requirements from competent regulatory authorities during dossier processing; etc.

In the above cases, the Investor shall be refunded the full amount paid during the subscription period and shall not bear any other costs or liability.

- Investor has paid into the Escrow Account but has not paid the full Deposit under the Share Subscription Form, or has not paid the Deposit on time, or the transfer description/payment details do not comply with the prescribed format, and DMX has determined the order to be an Invalid Subscription Order: the Investor shall be refunded the amount paid into the Escrow Account.
- Investor whose Valid Subscription Order has been allocated the right to purchase Shares and who has paid more than 100% of the Allocated Value: the Investor shall be refunded the entire excess over the Allocated Value.

- Investor with a Valid Subscription Order who fails to pay the Allocated Value in full, or fails to pay on time, or whose payment description does not follow the prescribed format/instructions, and whose payment has been rejected by DMX for such Valid Subscription Order: the Investor shall not be refunded the Deposit and shall not be allocated any Shares under the Allocation Result Notice for such Valid Subscription Order; the Investor shall be refunded only any overpaid amount as follows (if any):
$$\text{Refund Amount} = \text{Amount Paid During the Registration Period} + \text{Amount Paid During the Payment Period} - \text{Deposit due under the rules.}$$

3.4. Investor's representations and warranties

The Investor agrees and represents to DMX that the following statements are true, accurate, and not misleading as of the date the Investor signs/confirms agreement to the Share Subscription Form, and that such representations shall be repeated on (each) date the Investor pays the subscription price and takes ownership of the Shares:

3.4.1. For domestic Investors:

- Organizations: duly established and lawfully operating in Vietnam, with a specific and clear head-office and contact address and currently operating normally. If the person signing the Registration Dossier and other necessary documents in connection with the Share subscription is not the legal representative, a valid power of attorney must be provided;

- 3.4.5. The Investor fully understands its rights, obligations, interests, and the legal consequences of purchasing and investing in the Shares;
- 3.4.6. The Investor has obtained all necessary internal and third-party approvals and/or satisfied all necessary conditions under law, regulations of competent state authorities, and/or the Investor’s internal rules (where required) to accept and act under these Guidelines and the Share Subscription Form. The Investor is responsible for the legality of the source of funds used to purchase the Shares;
- 3.4.7. Any document signed by the Investor must be signed by the Investor in person (if an individual) or by the Investor’s lawful representative (if an organization).

4.2. Refund plan for Investors:

4.3. Method for recalling issued shares:

- For deposited shares: the Company shall coordinate with the Vietnam Securities Depository and Clearing Corporation ("VSDC") and depository members (the securities companies where Investors opened their securities accounts and deposited their Company shares) to carry out the share recall procedures in accordance with VSDC regulations.
